

NEW St. John's Churchyard/Cemetery Tariff of Rates March 21, 2023 (per Rob Moffat)

Interment rights: full lots, Sold in 2 sizes, (4 x 10 ft. and 4 x 8 ft.) The Cemetery by-law permits a maximum of two burials. **Option A ***, one casket and one cremation burial; **Option B**, two cremation burials. "Opening & Closing" fees are applicable for each burial. **\$4,300**

Additional cremation burials are permitted in full size lots.** For **each** additional *cremation* burial, the required fees charged are 1) a fee at the going cremation burial rate for cremation interment rights (\$1300) plus the respective going cremation rate for 'opening & closing'.

- 4' x 10' you can have up to 6 additional **cremations**.
- 4' x 8' you can have up to 4 additional **cremations**.

*In the event Option A is selected and the one cremation burial which is part of the original purchase is to take place before the full burial, the interment rights holder(s) must be aware the cremation must be disinterred at their expense, for a minimum cost of the "opening and closing" for cremated remains.

** This is contingent/subject to soil, fence, abutting graves/monuments, root conditions, prevailing BOA (Bereavement Authority of Ontario) regulations, distancing from trees and physical barriers and unforeseen future issues.

Interment Rights: crem. remains lot, for undersized lot/large cremation lot **\$ 2600**

Interment Rights for cremation remains: Memorial Gardens, 46cm x 46cm/18"x18"
(Normally sold in two's) **\$ 1300**

Additional cremation remains.....other areas (after 2 burials) **\$ 1300**

Opening & closing for full burial (summer) Apr. 16 – Nov. 30 **\$ 1900**

Opening & closing for full burial (winter) Dec. 1 – Apr. 15 **\$ 2200**

Opening & closing for burial of cremated remains.....(summer) **\$ 600**

Opening & closing for burial of cremated remains.....(winter) **\$ 700**

Additional Charge (premium for designated holiday/ weekend burial) for all burials **\$ 160**

Foundation for upright markers (4 feet deep) min charge is for 10 cu ft/ @\$65 cu ft plus \$100 to C & M

Late Notice fee (less than 48 hours for traditional full burial) **\$ 270**

Transfer of ownership (interment rights deed transfer) for third party sales or transfers **\$ 270**

Funerals held Saturday, Sunday, holidays or after 4:00 pm any day **\$270**

Installation of flat marker **Memorial Gardens \$220, Outside of Memorial Gardens, Larger Markers or Markers set in concrete to be priced individually.**

Care & Maintenance Fund.....Marker Fees are Set by the BAO

The following list of funds will be forwarded to the Care & Maintenance Fund:

Flat Markers 1,116 sq cm (173 sq inches) or over in area **\$ 100**

Flat Markers less than 1,116 sq cm (173 sq inches) in area **FREE**

Upright Markers less than 1.22 m high (4 ft) & less than 1.22 m long, including the base **\$ 200**

Upright Markers more than 1.22 m high (4ft.) or long, including the base **\$ 400**

The following fees will be forwarded to the Care & Maintenance(C&M) Fund

These funds have been included in the above fees. (40% of respective purchase price)

Traditional lot purchase **\$1720 to C & M**

Large Cremation remains only lot purchase **\$1040 to C & M**

Memorial Garden lot purchase **\$520 to C & M**
