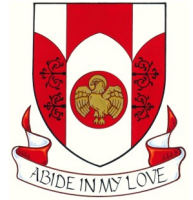

Every year, more and more people in our parish (over 55 %) are using the Pre-authorized Giving Program to fulfill their financial stewardship commitment to St. John's, Ancaster.

Benefits to You:

Simplicity – Once Pre-authorized Giving has been arranged, you no longer have to worry about writing weekly or monthly cheques.

Flexibility – You can increase, decrease or discontinue your givings at any time with about 2-4 weeks notice.

Environmentally Friendly – The Pre-authorized Giving Program eliminates the need for cheques and envelope boxes, thus saving trees.

Ease of Administration – The amount that is withdrawn is recorded on your account statement each month. This makes reconciliation of your bank account easy.

Allocation of Funds – You may allocate your monthly contributions to the everyday ministry budget, or to other church projects and ministries.

Virtually eliminates counting errors.

Benefits to St. John's:

Consistent cash flow enables the Corporation to plan the various ministries at St. John's knowing that there will be regular financial support.

Consistent cash flow enables the parish to meet its commitments and pay bills on time, thereby reducing interest charges.

This financial stability helps our clergy and lay leaders focus less on finances and more on ministry.

We hope that you will try this method. For you it will be a helpful way to meet your monthly financial commitment to the work of the parish and for our commitments to the important missions and ministry which our diocese, national and international church undertakes. Those who use the Pre-authorized Giving Program may place one of our laminated offering cards on the collection plate and in that way your gift will be "prayed over" at the altar.
